- II. Establishment of Board Quorum:

 - B. Members absent: Lindsay Davenport Solon, John Motyka
 - C. Guests: John and Nora Figueroa
- III. Unanimous acceptance of agenda
- IV. Minutes from September and October meetings approved
- V. Committee Reports
 - A. Finance Committee Ellen Simmons
 - 1. \$1,485.40 in checking and \$18,004.26 in savings
 - 2. 2021 budget adjustments proposed to meet an anticipated deficit
 - a) Donations capped at a total of \$100 (PAPA and SWAP)
 - b) Association Summer Picnic cut costs by grilling hot dogs instead of catering and save money on live music with possible sponsorships
 - c) Welcome Wagon will include one gift card instead of two
 - d) Sidewalk replacement monies will be tabled for 2021 and will be brought back in 2022 (passed unanimously in vote)
 - e) Raise Association dues to \$49.50 for 2021 (passed unanimously in vote)
 - B. Membership Committee
 - a) Holiday Walk with Fairmont will be Saturday, December 11th 6-8pm
 - a. Volunteers will pass out candy and area vendors may advertise specials. We will not underwrite free hot cocoas this year.
 - b. Prana Yoga in the park strip was a great success. Dani is happy to offer this again in the spring if we would like
 - c. Kids Block party was a success
 - C. Nominations Committee
 - 1. Seven open positions

- a) Bruce Geoffrion, Chris Cooper, Karen Bailey, Ellen Simmons are leaving
- b) John Motyka and Sam Welch are undecided
- c) Jim Miklos will stay on and Sue Mallernee will run again
- 2. Thanksgiving is the deadline for nominations will go to a vote only if enough people decide to run

D. Beautification Committee

- 1. There are 180 drains in our association we need to affix medallions to each one
 - a) The maps detailing their locations overlap and are a bit confusing
 - b) Nadine and Sierah will work together to zone the medallions out and be ready for installation in the spring
- 2. Sierah will retain the role of gardener for the pocket gardens but she is need to step down as head of the committee. She is President-Elect of PAPA and her duties will increase.
