Traffic Calming Petition Progress

Southwood Park, Foster Park, and Fairmont Associations will submit a Traffic Calming Petition to reduce our neighborhood speed limit from 30MPH to 25MPH. We collected half the needed signatures by mail in January. We are making progress toward our goal. Why are we doing this?

Safety First! The average risk of death for a pedestrian reaches 10% at an impact speed of 23MPH, 25% at 32MPH, and 50% at 42MPH (Source: AAA Foundation for Traffic Safety). Collisions happen and our winding streets belong to all users-walkers at crosswalks, bikers, and joggers—not just cars. Speed kills if you're not in a car.

Perception vs Reality: The City speed limit of 30MPH is a cookie cutter standard. Are we a cookie cutter neighborhood with standard sight-lines and widths? No! Did you know it isn't considered speeding until 35MPH? Traffic engineers nationwide calculate a "tolerated speed", adding a cushion of 5MPH. City believes we have a speed perception problem rather than an actual speeding problem.

What about enforcement? We purchased a radar sign to prove where speeding happens in the neighborhood. It resulted in more patrols on Fairfield. There are limited police patrols, but lowering our speed limit will increase the consequences for those who do get stopped for speeding.

But I don't see speeding on my street! Some streets are lucky; others are not. Year after year, speeding is a top concern shared by neighbors. Please consider our neighbors who experience this problem daily. Help them out by signing the petition. It's a quality of life issue.

What can I do? If you haven't already, sign the petition on page 2. Send it to Steve McCord at 4125 Indiana Avenue. You can also drop it off or email a photo of it to the Association at Southwood Park@yahoo.com. This will keep a volunteer from knocking on your door this summer as we seek to finish the petition!

Crime Prevention Tips

What can you do?

- There are many catalytic converter thefts from cars citywide. Report ALL suspicious activity to 911. Better safe than sorry.
- Garages are especially at risk, keep them locked.
- Keep porch lights on. Install motion detectors.
