I. North Campus update - Steve reported he attended a meeting with Councilman Geoff Paddock, Tim Ehlerding (Ambassador Enterprises director of real estate), Kody Tinnel (Foster Park NA), and Melissa Kurten (Oakdale NA) regarding the "North Campus" block of the Summit on Rudisill Blvd.

Ambassador would like to pursue a high-return use for the now empty property. Based on the group discussion, development of market-rate townhomes may be an option that has the greatest amount of support - as opposed to apartments or commercial development. Any type of development is likely to encounter some resistance, but the consensus was this may be the easiest. Ehlerding expects to have early feasibility studies completed by spring.

[NOTE: This discussion took place at the beginning of the meeting.] 1. He has been in the position for 15 years; he interacts and communicates with every department of the city. He is open to any and all conversations and invites everyone to

2. The roundabout at Old Mill has been on the City's agenda for about a year and they are now ready to begin. It would take about \$400,000 to bring it to what it should be including... widening the traffic pattern. Budget constraints demand that the renovation will be done in phases over a few years.

3. Soon the city will raze the entire circle and ready it for native plantings in the spring. The plantings will be seasonal blooming so there is always color. Native plants will eliminate the need for watering and maintenance. Water and electric will be capped but still accessible if needed in future.

4. Overall design will be a sloping incline toward the middle with 15-20ft of turf grass (maintained by the city) around the perimeter. Native plantings will complete the design for now and in two to three years a more elaborate design including a monument appropriate for Southwood Park (something similar to the pillars). New and updated signage including directional chevrons will be installed as well. [Planting list attached]
