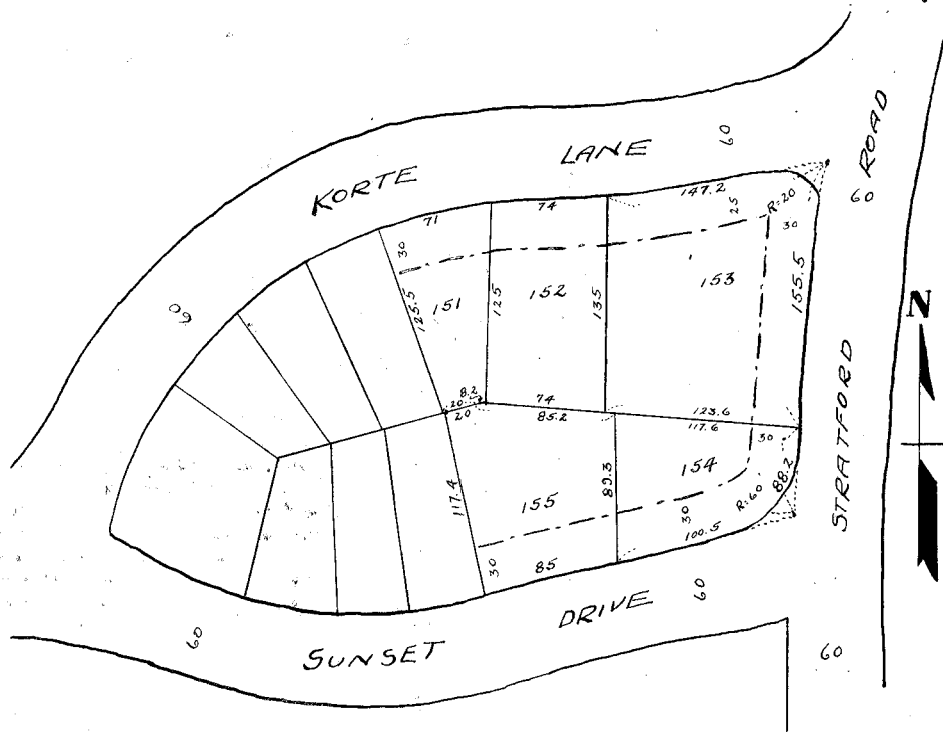


# AMENDED PLAT OF SOUTH WOOD PARK ADDITION SECTION "C" to the City of Fort Wayne



The undersigned, HILGEMAN & SCHAAF, a corporation organized and operating under the laws of the State of Indiana, being the owner of certain tracts and parcels of land known and described as follows, to-wit: Lot numbered 54, 55, 56, 57, 58, 66, 67, 68, 69 of South Wood Park Addition, Section C, as recorded in Plat Book 8, pages 72 and 73 of the records of Allen County; does hereby subdivide and replat said land in accordance with the plan herein shown to be known as AMENDED PLAT OF SOUTH WOOD PARK ADDITION, SECTION C" to the City of Fort Wayne. The lots are numbered 151, 152, 153, 154 and 155, and all dimensions are noted in the plat in feet. The south 3 feet of lots numbered 151 and 152 and the north 3 feet of lots numbered 154 and 155, and the west 3 feet of lot numbered 154 and the east 2 feet of lot 155; also a strip 2 feet in width along and adjoining each side of the lot line between lots numbered 151 and 152, 152 and 153, 153 and 154, and a strip 2 feet in width along the east side of the west line of lots numbered 151 and 155, shall be reserved as an easement for the construction and maintenance of lines of sewers, gas mains, water mains, electrical conduit or other public or quasi-public utilities for the benefit of said lots. All of said lots shall be subject to the same restrictions and limitations as to the use thereof as are in force and pertain to the lots in South Wood Park Addition, Section C" aforesaid insofar as these do not interfere with the newly platted lot lines.
